The Economic Consequences of Parental Union Dissolution (Job Market Paper)

Abstract: This paper examines the impact of parental union dissolution on the economic resources available to children. Using the 1968-2019 PSID, and multiple measures of economic well-being, I compare the dynamic consequences of parental separation before and after the 1996 welfare reform using an event study model with child fixed effects. My results suggest that welfare reform has contributed to worsening economic outcomes following parental union dissolution.

Will Work for Insurance: Estimating the Causal Impact of Health Insurance on Labor Supply
(Masters Thesis, 2016)

Abstract: The Young Adult Coverage Expansion took effect on September 23, 2010. Under this provision, individuals are allowed to remain on their parent's health insurance plan through age 26. This paper uses a control function to estimate the second stage labor market effects using mandate eligibility as an instrument. Using data from the 2006 to 2014 March Current Population Survey, I find the mandate caused substitution from full-time to part-time work.
